
FLIP-R's self-locking kit

FEATURES AND BENEFITS


- > It allows to fasten the FLIP-R pipe clamp on strut channels or GIA's brackets.

- > During assembly the item should be tightened enough to make sure the self-locking device is deformed enough to ensure a good grip on the channel (3 Nm tightening torque is recommended).







SCREW AND NUT

M6 Steel 4.8 EN ISO 898.1 with electro zinc-plating 7-8 μm

"V2" class according to UL 94 regulation

INSTALLATION

- > Insert M6 nut in the locking kit.
- > Insert the screw into the pipe clamp's fixed part from the top and partially screw it in the self-locking tool.
- > Set the assembly at any point of the strut channels according to your needs and tighten the screw.

INSTALLATION TOOLS AND RECOMMENDATIONS

The self-locking kit can be used on strut channels that are as high as 15 mm or higher than that (A), with a thickness (S) included between 1,5 and 2,5 mm, at a distance (D) that is as wide as to allow the insertion of the item, i.e. 14<D<18 mm.

During assembly the item should be tightened enough to make sure the self-locking device is deformed enough to ensure a good grip on the channel (3 Nm tightening torque is recommended).

The pipe clamp must be assembled with the self-locking kit by using screws and washers.
